The Kennel will maintain a sanitary and safe environment at all times and will provide routine feeding and exercise schedules throughout each day. All pets boarded or otherwise handled and cared for by The Kennel without liability to The Kennel for loss or damage from diseases, death, running away, theft, fire, injury to persons, other dogs, or property by said animal, or other unavoidable causes, due diligence and care having been exercised. The Kennel shall have the right to brush or any other grooming necessary for the well-being of said animal during the time said animal is boarded. If the animal should become seriously ill, The Kennel has the right to call the owners veterinarian or one of our choosing, to administer medicine or give other advisable attention and such expenses shall be paid promptly by the owner of the animal. If any charges for boarding, medicine or veterinary services are not paid for within ten days after they are due or if the animal is not called for within ten days after time of return, the animal will be sold within ten days after this period by The Kennel, publicly, privately, or otherwise for the best price available. Notice in writing of such intended sale shall be mailed by registered mail to the owner of the animal at the address given hereon, not less than ten days of such intended sale, and no further notice shall be deemed necessary. The owner represents legal ownership of the animal, certifies the animal is not mortgaged in any way and verifies that said animal has not been exposed to distemper or rabies within the last thirty days. In the rare and unfortunate event that your pet dies in our care your pet will be taken to your designated veterinarian and maintained for pick-up or further instruction.
