Pets are tethered while in the bathtub and/or on the grooming table while under constant supervision. All pets handled and cared for by The Kennel without liability to The Kennel for loss or damage from diseases, death, running away, theft, fire, injury to persons, other dogs, or property by said animal, or other unavoidable causes, due diligence and care having been exercised.

If the animal should become seriously ill, The Kennel has the right to call the owners veterinarian or one of our choosing, to administer medicine or give other advisable attention and such expenses shall be paid promptly by the owner of the animal. In the event said animal should die while in the care of the Kennel, arrangements will be made with the above-named Veterinarian or one of the Kennel's choosing, to hold said animal until the owners return. The owner represents legal ownership of the animal, certifies the animal is not mortgaged in any way and verifies that said animal has not been exposed to distemper or rabies within the last thirty days.
